Meeting Commenced: 1900

COMMITTEES & EVENTS:

Playground: The previous vote for turf funding for the gaga pit at \$3,000 will not be enough. More work needs to be done to have it installed properly, and as a result, the cost will be closer \$5,000. Meredith made a motion for a vote to approve spending up to \$5,000 for the installation of turf in the gaga pit, and it was seconded. It was a unanimous vote to increase the budget accordingly.

Spirit Walk: Not present.

Book Fair: Not present, proxy update. The book fair was very successful, with about \$12,000 in sales (not all of that is profit). Taylor would like to thank all the volunteers and co-chairs for their

help. The Spring Book Fair will be 4/24-28. Going forward, Taylor would like to move the book fair to late October-early November, to avoid too many spending events so close together heading into the holidays.

Santa's Secret Workshop: Not present, proxy update. Overall the event was successful. There will be some discussion going forward regarding changes to make it work better.

Sweets Treats & Eats: Not present, proxy update. The Candy Gram sale went well, raising over \$500.

Roller Skating: The event had 81 skaters in attendance, which is lower than in the past. Hoping to have more people come out for the next event in March.

Plant Sale: Inquiries were made for an Easter flower sale. The poinsettia sale went okay, however they are looking to add or switch to wreaths or table top decor instead.

POSSE: Not present, proxy update. Including Taylor, there were only six responses to the sign up link. Getting those volunteers fingerprinted is next. If any volunteers are interested but unable to afford the cost of fingerprinting, please see a board member about financial assistance. They are also hoping to come up with a new name for the group.
